





1. Hiring of Telephones	681/01	Hiring of telephones and payment of Value Added Services including Internet connectivity/Broadband
2. Renting of Circuits	681/02	Renting of circuits including Terrestrial, bandwidth on submarine cable, INMARSAT, SATCOM, Wireless etc.
3. Management of Tele-Communication Networks	681/03	Management of Tele-Communication networks including procurement and maintenance of all kinds of communication items/technology/ services and will also include: (a) All categories of telephony and communication network equipments, Radio Access Network items, Telecom network/ Telephone-related items, Media Secrecy Units, etc. (b) Telecom consultancy (design, optimization and audit) & training, power supply, environment control equipment, fire protection equipment, data centres, test equipment and tools etc. (c) Any satellite communication related items/ services to meet operational requirements. (d) Any communication equipment/ services necessitated due to improvements in technology.
