2. It is observed from above table that provisional payments made with the approval of competent authority but sanction for the same not received till date.
3. Hence , it is directed to all audit sections , to link the request for provisional payment with this database and put up the case as per para 231 of Defence Accounts Code, which states that in case where it is found that administrative authorities fail to be vigilant in applying promptly for additional allotment of funds where provisional payments have been authorized , PCDA/CDA will ask the authority concerned (endorsing a copy to the next higher administrative authority) to take urgent action in the matter, adding a warning that further Provisional Payments will not be made unless application for additional allotment, with reasons in support, is

submitted through PCDA/CDA promptly. If this warning has no effect, Provisional Payments must be refused & this action be reported to HQ (Army) and Integrated Finance through CGDA thus, restricting Provisional Payments only in exceptional cases as per para 231 of Defence Accounts code rather than as matter of routine.

4. While releasing of payments statement of case may be called for to render audit report for obtaining allotment of funds under head charged.
