

In this connection, necessary instructions may be issued to all LAOs under their control for Audit of Accounts accordingly in a time bound manner.

3. The balances outstanding in AROBs in respect of Military Farms would need to be updated and cleared on priority, bringing down these balances to the minimum possible immediately.

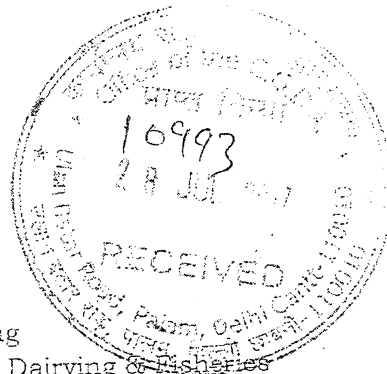
2. In this regard, it is requested to take immediate necessary steps in pursuance of the above decision and action taken note be submitted at an early date.
