Subject: Grant of IIIrd Financial Up gradation under the MACP Scheme for
the Central Govt Civilian Employees . DEOs


Having been declared FIT by Screening Committee for placement in the higher pay, PCDA(WC) Chandigarh has approved the grant of IIIrd financial up gradation under the MACP scheme as mentioned in Colum 5 of Annexure "A" under 7th CPC Pay Matrix with effect from the date shown against each as introduced by DOP&T vide No. 35034/3/2008-Estt(D) dated 19.05.2009, who have completed 30 Years of regular service as shown in Annexure "A" with effect from the date mentioned against the name of the officials .

2 The placement in the pay band of Rs.9300-34800/ to the next level as mentioned in Coloumn 5 of Annexure "A" for the grant of financial benefits through up-gradation under the MACP scheme, is only on personal basis in the immediate higher grade pay/grant of financial benefits only and shall not amount to actual/functional promotion to the employee concerned and MACP shall have no relevance to his seniority position. Their pay shall be fixed as per extant orders on the subject.

3. The grant of higher grade pay under MACP scheme shall be conditional to the fact an employee, while accepting the said benefit, shall be deemed to have given his unqualified acceptance for regular promotion on occurrence of vacancy subsequently. In case he/she refuse to accept the higher post on regular promotion subsequently, he/she shall be subject to normal deferment to the period of debarment due to refusal for further financial up gradation till he/she agrees to be considered for promotion again as prescribed in Para 25 of Annexure-I to the above letter of DOP&T for the grant of benefit under MACP scheme.
