The case relates to Fixation of pay on restructuring of Cadre of Artisan Staff in Defence Establishment in modification of 6th CPC recommendations. CGDA has again referred the file to this Section for clarifying whether MoD ID No. 11(5)/2009-D(Civ-I) dated 14.06.2010 is also applicable to HS appointed and also promoted between 01.01.2006 and 14.06.2010. And whether clarification given in MoD Id No. 11(5)/2009-D(Civ-I) dated 29.12.2011 regarding relaxation of qualifying service is also applicable in such cases.

2. In this context, it is stated that this case was earlier examined by this Section vide Note 2 & 8/ante. At Note 2/ante vide para 6 it was informed that "the existing artisan staff on the date of issuance of letter 14.06.2010 is required to be placed in the revised structure with effect from 01.01.2006 in relaxation of conditions as one time measure".

3. Therefore, it is quite clear that MoD letter dated 14.06.2010 is not applicable to HS appointed and also promoted between 01.01.2006 and 14.06.2010 for the purpose of restructuring of Artisan Cadre. It is also clarified that relaxation may not be given in the qualifying service while restructuring the Cadre in terms of MoD letter dated 14.06.2010.

4. If approved we may return the file to CGDA with above comments.
