**Subject: Recommendations of 7<sup>th</sup> Central Pay Commission -Applicability to the pay scales of Casual Labourers with Temporary status.**

The undersigned is directed to say that on the implementation of the recommendations of the 7<sup>th</sup> Central Pay Commission as per Government of India Notification dated 25<sup>th</sup> July, 2016, the Casual Labourers with Temporary Status will continue to receive their wages with effect from 01.01.2016 as per provisions of the Casual Labours (Grant of Temporary Status & Regularisation) Scheme, worked out on the basis of the pay scales of Group 'C' as per Level 1 of the Pay Matrix recommended by the 7<sup>th</sup> Central Pay Commission and approved by the Government provided they are matriculate. In case of the similarly placed non-matriculate Casual Labourers with Temporary Status the above benefit of wages w.e.f. 01.01.2016 may be extended only after imparting the requisite training by the respective administrative Ministries/ Departments on the lines indicated in the MOF O.M. No. 1/1/2008-IC dated 24.12.2008.
