Subject : Promotion of Asstt. Accounts Officers to Accounts Officer's grade against the vacancy year 2021.

HQrs office vide their letter cited under reference has approved **in situ promotion** of AAOs under this organization as per Annexure-1 to the grade of Accounts Officer in Level-9 of the 7th CPC Pay Matrix (Rs. 53,100 to Rs. 1,67,800). The promotion is to be granted with immediate effect or from the date of assumption of charge of new post, whichever is later.

2. Before promoting these AAOs it may be ensured that none of the circumstances enumerated in Para 2 of the DOP&T OM No. 22011/4/91-Estt. (A) dated 14.09.1992 have arisen. If such circumstances have arisen, the promotion shall not be released and instead considered as if the case of the officer concerned has been placed in Sealed Cover by the Departmental Promotion Committee in terms of Para 7 of the said OM and on intimation to his effect be given to the HQrs Office.

2 It is also intimated that all the AAOs have been granted **in situ promotion** and after the promotion to AO's grade they may be transferred to different offices/Organisation by the HQrs office based on the recommendation of the DAPB, as per the administrative requirement or vacancies existing at a particular station/office.

3 Immovable Property Return of the officer, as on date of promotion to the Accounts Officer's grade, duly verified, may also be forwarded within 15 days from date of promotion.

4 The assumption of charge in AO's grade may be sent to this office for publication of Part-II OO.

5 Ink signed copy of this order may not be awaited. No separate promotion order will be issued in this regard.
